Item 4: Resignation, Removal or Election of Registrant's Directors or Officers

The Board of Directors of Aboitiz Equity Ventures, Inc. (AEV) elected Mr. Edwin R. Bautista as Director and member of the Board Executive Committee effective immediately, to serve the unexpired term of Mr. Antonio R. Moraza.

Mr. Bautista, 58 years old, Filipino, is currently a Director, and the President and Chief Executive Officer of Union Bank of the Philippines (UnionBank), a publicly-listed company. He is also a director in City Savings Bank, Inc., Union Properties, Inc., First Union Plans, Inc. and First Union Direct Corp. Mr. Bautista also served UnionBank in various capacities: as Chief Operating Officer from January 1, 2016 to December 31, 2017, Senior Executive Vice President from 2011 to 2015, Executive Vice President from 2001 to 2011, and Senior Vice President from 1997 to 2001.

Mr. Bautista earned his Bachelor of Science in Mechanical Engineering degree from the De La Salle University. He also completed the Advance Management Program at the Harvard Business School.
