Please be informed that a consortium comprised of Unisys Philippines, AC Infrastructure Holdings Corporation and Aboitiz InfraCapital, Inc. submitted an unsolicited proposal under RA 7718 or the BOT Law to the Philippine Statistics Authority on August 13, 2018 for the design and development of a national identity infrastructure solution, which is intended to collect, store, maintain, manage, and authenticate identity information of individuals.

The consortium has proposed that it be granted a 17-year concession to develop and implement an expedient and comprehensive solution that will provide a safe and secure identification and benefits payment mechanism for individuals transacting with government.
