AEV International Pte. Ltd. (AEV International), a wholly-owned subsidiary of Aboitiz Equity Ventures Inc. (AEV), appointed (i) The Hongkong and Shanghai Banking Corporation Limited (HSBC) and Standard Chartered Bank as Joint Global Coordinators; and (ii) DBS Bank Ltd., HSBC, Mizuho Securities (Singapore) Pte. Ltd., MUFG Securities Asia (Singapore) Limited, and Standard Chartered Bank as Joint Lead Managers and Joint Bookrunners to arrange a series of fixed income investor meetings and conference calls in HongKong, Singapore, and London commencing on January 6, 2020. An offering of U.S. dollar-denominated Regulation S only senior unsecured notes (the "Notes") may follow, subject to market conditions. The Notes, if issued, are expected to be unconditionally and irrevocably guaranteed by AEV and unrated.
