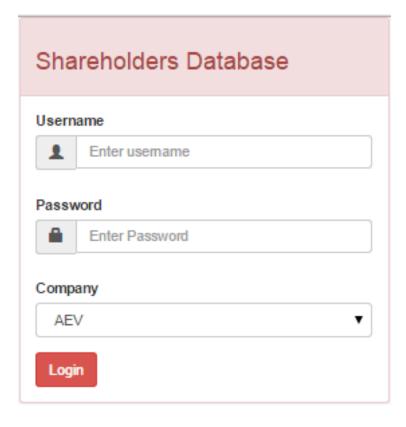

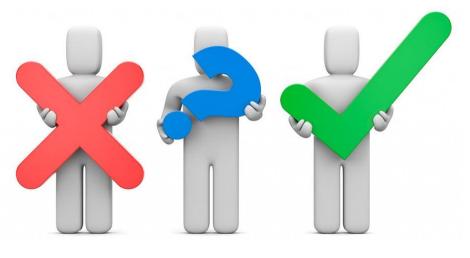

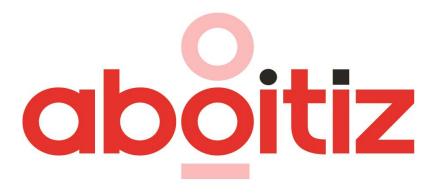
## **Third Party Auditor Verification Process**

- BEI counts the votes
